ADMISSION NOTICE

ACADEMIC SESSION 2026-27

V.V. Giri University, Siwan invites applications from eligible candidates for admission to various academic programmes for the Academic Session 2026-27.

The University offers programmes under a wide range of Faculties, providing students with opportunities to pursue studies in professional, technical, scientific, management, social science, arts and other emerging fields.

1. The University may issue a Certificate, Diploma, or any Degree upon completion of two or three years of the programme, in accordance with NEP 2020.
2. Credit Transfer Facility shall be available to students in case the students decide to opt out during the session of the programme.
3. Multiple Entry and Exit Facility for the students will be available.

Candidates are advised to carefully check the eligibility requirements and other admission-related information before applying. Admission to a particular programme will be subject to the availability of seats and fulfilment of the eligibility and other requirements prescribed by the University.

ELIGIBILITY FOR ADMISSION

The eligibility criteria for admission will vary according to the programme and level of study.

In general:

- For Certificate and Diploma programmes, candidates must possess the qualification prescribed for the respective programme.
- For Undergraduate programmes, candidates must have passed Class 12 or an equivalent examination, as applicable.
- For Postgraduate programmes, candidates must possess the relevant Bachelor's Degree or equivalent qualification.
- For programmes governed by professional or statutory bodies, the applicable eligibility criteria and requirements of the concerned authority shall also apply.

Candidates are requested to check the programme-specific eligibility requirements before submitting their application.

ADMISSION PROCEDURE

Admission may be offered on the basis of merit, entrance examination, counselling, interview, aptitude or skill assessment, or any other procedure prescribed by the University for the concerned programme.

The admission process may vary depending upon the programme.

Candidates will be required to complete the prescribed application process, provide the necessary academic and personal details, submit the required documents and complete other formalities as communicated by the University.

DOCUMENTS REQUIRED

Candidates may be required to submit or produce the following documents, wherever applicable:

- Recent passport-size photograph and signature
- Class 10th - Matriculation Certificate and Mark Sheet
- Class 12th - Intermediate Certificate and Mark Sheet
- Graduation or Postgraduate Mark Sheets and Certificates
- Transfer Certificate/School Leaving Certificate

- Migration Certificate
- Valid Government-issued Identity Proof
- Disability Certificate issued by the competent authority, wherever applicable
- Category/EWS/Domicile Certificate, wherever applicable
- Entrance Examination Score Card, wherever applicable
- Any other document required for the concerned programme

Original documents may be required for verification at the time of admission.

PROVISIONAL ADMISSION

Admission offered to a candidate shall remain provisional until the required documents and eligibility conditions have been verified.

The University reserves the right to cancel admission if a candidate is found ineligible or if any information or document submitted during the admission process is found to be incorrect, incomplete or invalid.

PAYMENT OF FEES

Candidates who are offered admission will be required to deposit the prescribed admission fee and other applicable charges within the stipulated period.

Failure to complete the required admission formalities or deposit the prescribed fee within the specified time may result in cancellation of the admission offer.

Any refund of fees, wherever applicable, shall be governed by the applicable rules and policies of the University.

IMPORTANT INSTRUCTIONS

- Submission of an application does not guarantee admission.
- Candidates should ensure that all information provided in the application is correct and complete.
- Admission will be subject to fulfilment of the prescribed eligibility criteria and availability of seats.
- Candidates should provide an active mobile number and e-mail address for admission-related communication.
- The University may communicate important updates, schedules and instructions through its official communication channels.
- Candidates are advised to regularly check for admission-related updates.
- Admission may be cancelled if incorrect information or invalid documents are submitted.

- Admissions to programmes requiring approval, recognition or compliance with the norms of statutory or professional authorities shall be subject to the applicable requirements.
